Thefts of pumps, re-surfacing and re-plastering

During the planning of scheduled closures of pools/spas for re-surfacing and re-plastering, there has been 4 pool/spa pumps/filters that have been stolen within HOA #1. Pools #1 (Calle Avila), #2 (Paseo Real) and Pool # 5 (Camino Jalan) have been affected. We have been advised that other HOAs within Cathedral Canyon have been victimized with the theft of these highly-valued pieces of equipment. A police report has been filed and along with their recommendations, your board and Desert Management are exploring options to remedy the situation.

Pools & Spas Re-Plastering / Re-Surfacing Projects Underway

This costly but necessary project will begin September 27. The scheduled closures starts is as follows: Pool #1 - September 27, Pool # 3 -October 5, Pool #4 - October 18. All projects will finish in 3-4 weeks. During this time, both Pools/Spas # 2 (Paseo Real) and #5 (Camino Jalan) will be *OPEN FOR USE*. To spread the cost over 2 fiscal years, the work for the remaining Pools/Spas # 2 and #5 will take place in early 2022.

Coachella Valley Water Leak Over the summer, two water leaks were reported on Camino Jalan. CV Water is responsible for the damage which includes debris in the water lines. The board is requesting reimbursement for the repair costs.
